TERMS & CONDITIONS

DEPOSIT & ACCEPTANCE OF TERMS

A deposit of 20% of quoted costs is required to secure your reservation, payable within 5 business days. A further payment of 30% of the quoted food costs is required no later than 7 days prior to the function. Bookings are not confirmed until initial deposit is paid in full and the signed Acceptance of Terms document has been received.

CANCELLATION

All cancellations must be confirmed in writing to Bress and only cancellations made more than 180 days prior to the confirmed event are eligible for a refund of the initial deposit. Cancellations made within 14 days of the event will be charged the full value of the event as per the initial quote.

TRANSFER OF DATE

Any transfer of date is at the discretion of Bress and is subject to availability. Change of date must be requested in writing.

MENU & DIETARY REQUIREMENTS

Due to a lot of the menu being harvested from the Bress Garden, menu selections are subject to weather conditions.

With prior notice, Bress is able to cater for vegetarians and gluten intolerance, however other dietary requirements cannot be catered for.

FINAL GUEST NUMBERS

Final guest numbers, including advice of allergies/dietary restrictions, are to be confirmed 7 days prior to the event. Changes to confirmed guest numbers are not accepted beyond this time and catering for dietary requirements cannot be guaranteed.

FINAL PAYMENT

The balance of payment, based on final guest numbers minus the deposits paid, is required on the day of the event.

BYO

Bress is strictly a NO BYO venue. Any alcohol brought onto the premises will be disposed of.

DAMAGES

The person signing the 'Acceptance of Terms' document shall be held responsible for any damage to the Bress property, fixtures or fittings, whether inflicted by their own actions or through their guests or contractors/suppliers. This person shall be liable for the cost to repair or replace damaged items.

EVENT STYLING

If the services of Bress staff are required for any set up/styling beyond the inclusions of the event package, you will be charged accordingly

Any light/fixture installation needs to be pre-approved by Bress and use of the Bress forklift for these installations will be charged at a rate of \$75 per hour.

We ask that any candles being used are 'dripless' or are on a base. Damage to linen from candle wax will be charged for as per previous point.

ENTERTAINMENT

Any entertainment arrangements must be communicated to Bress in writing. All costs incurred for performance, staging, lighting etc are the responsibility of the customer.
